Significant Announcements During the Week:

- GenusPlus (GNP-AU) has been awarded two contracts under Fortescue's decarbonisation plan in Western Australia. The contracts have a combined value of approximately A\$50M, with contract works estimated to be completed by mid 2025.
- Perenti (PRN-AU) announces its underground mining business Barminco has been awarded a A\$393M three-year contract at Regis Resources' Duketon Operations in Western Australia.
- Austal (ASB-AU) has rejected an A\$1.02B takeover offer from Hanwha Ocean, citing it was not satisfied that mandatory approvals would be secured by Australian and US regulators due to the sensitivity of its operations.
- Boart Longyear Group (BLY-AU) notes conditions precedent to plan of arrangement have been satisfied or waived, with the closing of the transaction with American Industrial Partners now expected to occur on 10 April Toronto time.


